12) APCO Report (Verbal)

OF DIRECTORS. MR. GORMAN WILL BE REPRESENTING THE CITY OF RIDGECREST. FISCAL YEAR 2023-2024 ADDED ROUGHLY \$320,000 TO THE DISTRICTS RESERVES, NOW TOTALLING \$3.1 MILLION DOLLARS. THE DISTRICT ANTICIPATES A BALANCED BUDGET FOR FISCAL YEAR 2024-2025. THE DISTRICT WILL BE WORKING WITH KERN COUNTY HUMAN RESOURCES TO UPDATE CLASSIFICATIONS AS WELL AS ADJUST SALARIES AMONG THE ADMINISTRATIVE STAFF TO CORRECT INEQUITIES. SALARY ADJUSTMENTS ARE ON HOLD UNTIL KERN COUNTY AND SEIU REACH A CONTRACT AGREEMENT. EKAPCD STAFF IS ON CALLS WITH THE STATE DAILY, MONITORING WILDFIRE IMPACTS AND ISSUING HEALTH ADVISORIES ACCORDINGLY.
