



Sulfur Oxides

Toxin of the Quarter

ulfur Oxides are gases that form when Sulfur bonds with Oxygen. This may happen naturally in the environment or through industrial processes. Worldwide, most sulfur oxides in the air are produced by power plants that burn sulfur-containing fossil fuels such as coal or petroleum to produce electricity. Locally, most sulfur dioxides are generated by traffic (including trucks and trains). The most common sulfur oxides found in the air are sulfur dioxide (SO₂) and sulfur trioxide (SO₃). Sulfur dioxide is a heavy, colorless gas that has the smell of a just-struck match. It is naturally emitted during volcanic eruptions and by fumaroles which are vents that open up from the Earth's crust and emit steam and gases. Sulfur dioxide

may combine with oxygen in the air and form sulfur trioxide. SO_3 is the precursor to acid rain. Acid rain occurs when sulfur trioxide and water in the atmosphere react with each other and form sulfuric acid (H₂SO₄).

Sulfur dioxide has many useful purposes. It is used in the winemaking process to stop wine from spoiling. It is also used as a preservative for fruit. Its antimicrobial properties make it very valuable in the food and beverage industry. Historically, it was used as a fumigant to get rid of

pests as well as disease. Sulfur dioxide was used in the 19th century to eliminate smallpox, measles and scarlet fever. The fumes stopped the viruses from replicating but little was known about the effects of the exposure of this gas to the human respiratory system and to the environment.

Sulfur dioxide's lifespan in the atmosphere is 4-10 days as a component of smog. In that short time, SO₂ can cause great damage to many things. Acid rain can harm plants, trees, crops, textiles, building materials, animals and humans. It has the ability to destroy ecosystems. Some freshwater lakes are unable to be in

habited by wildlife due to the contamination of its water by acid rain. SO2 turns leaves yellow and decreases the growth rate of crops; its corrosiveness can even destroy statues over time.

Long-term exposure to sulfur dioxide can lead to respiratory issues and even premature death in humans. Irritation of the eyes and throat may occur. The inhalation of SO_2 causes airway constriction and an increase in the flow of mucous which also contributes to blockage of the air passages. Asthmatics especially have a hard time when sulfur dioxide is present. It aggravates other respiratory illnesses as well, such as emphysema and it even affects those who have heart



disease. Studies have shown an increase in hospitalizations for respiratory issues on days where there is an abundance of sulfur oxides in the air. Children and the elderly are highly susceptible.

The Eastern Kern Air Pollution Control District (District), Environmental Protection Agency (EPA), and California Air Resources Board (CARB) have taken measures to actively reduce emissions of sulfur oxide (SOx) emissions in the atmosphere. One way to reduce SOx emissions is to control the amount of sulfur in

fuel that is burned (low sulfur fuels). Another methodology is utilizing Flue Gas Desulfurization; sulfur dioxide is removed from the exhaust gas before it is emitted into the atmosphere.

The District currently monitors multiple several facilities in its jurisdiction to assure sulfur dioxide emissions do not exceed regulation limits.

District Rule 407 establishes a Sulfur emission standard for the District; however, there are other regulation the District utilizes to minimize SO_2 emissions. Currently, the District meets the National Ambient Air Quality Standard for sulfur dioxide.
